ADOPTION OF WISCONSIN UNIFORM DWELLING CODE

- **1.1** AUTHORITY. These regulations are adopted under authority granted by s.101.65, Wisconsin Statutes.
- 1.2 <u>PURPOSE</u>. The purpose of this ordinance is to promote the general health, safety and welfare and to maintain required local uniformity with the administrative and technical requirements of the Wisconsin Uniform Dwelling Code.
- 1.3 <u>SCOPE.</u> The scope of this ordinance includes the construction and inspection of one-and two-family dwellings, other residential out buildings, garages, decks, etc., built since June 1, 1980.

Not withstanding s. Comm 20.05, the scope also includes the construction and inspection of alterations to one- ane two-family dwellings built after June 1, 1980. Because such projects are not under state jurisdiction, petitions for variance and final appeals under ss. Comm 20.19 and 20.21, respectively, shall be decided by municipal board of appeals. Petitions variance shall be decided per s. Comm 20.19(Intro) so that equivalency is maintained to the intent of the rule being petitioned. As the board of appeals approves petitions for variance, the chief inspector is granted the power to apply the results to similar circumstances by precedent.

Not withstanding s. Comm 20.05, the scope also includes the construction and inspection of detached garages serving one- and two-family dwellings. The building structure and any heating, electrical or plumbing systems shall comply with the Uniform Dwelling Code. Petitions for variance and appeals shall be handled as in the previous paragraph.

In performing his duties, the building inspector will apply standards for the uniform dwelling code in effect at the time of the construction project.

- 1.4 <u>WISCONSIN UNIFORM DWELLING CODE ADOPTED.</u> The Wisconsin Uniform Dwelling Code, Chs. Comm. 20-25 of the Wisconsin Administrative Code, and all amendments thereto, is adopted and incorporated by reference and shall apply to all buildings within the scope of this ordinance.
- 1.5 <u>BUILDING INSPECTOR</u>. There is hereby created the position of Building Inspector, who shall administer and enforce this ordinance and shall be certified by the Division of Safety & Buildings, as specified by Wisconsin Statutes, Section 101.66(2), in the category of Uniform Dwelling Code Construction Inspector. Additionally, this or other assistant inspectors shall possess the certification categories of UDC HVAC, UDC Electrical, and UDC Plumbing. (Note: Contact the Division of Safety & Buildings at (608) 261-8500 for certification information).
- 1.6 <u>BUILDING PERMIT REQUIRED.</u> No person shall alter, in excess of \$5,000 value (material & labor) in any twelve-month period, build, add onto or alter any building within the scope of this ordinance without first obtaining a building permit for such work from the building inspector. Any structural changes or major changes to mechanical systems that involve extensions shall require permits.

Restoration or repair of an installation to its previous code-compliant condition as determined by the building inspector is exempt from permit requirements. Residing, re-roofing, finishing of interior surfaces and installation of cabinetry shall be <u>exempted</u> from permit requirements.

Any original connection to electrical service or reconnection to electrical service is subject to this inspection permit ordinance with the following exemptions.

- A. The reconnection has occurred within where the cause of the disconnection related to non-payment of utility bill.
- B. The reconnection is due to any type of repair not involving the service panel.
- 1.7 <u>BUILDING PERMIT FEE.</u> The building permit fee shall be determined by resolution.
- 1.8 <u>PENALTIES.</u> The enforcement of this section and all other laws and ordinances relating to building shall be by means of the withholding of building permits, imposition of forfeitures and injunctive action. Forfeitures shall be not less than <u>\$25</u> nor more than <u>\$1,000</u> for each day of noncompliance.
- 1.9 <u>EFFECTIVE DATE.</u> This ordinance shall be effective <u>May 1, 2004</u>, upon passage and publication as provided by law.
