## ORDINANCE NO. 2020 -04 AN ORDINANCE TO AMEND THE COMPREHENSIVE PLAN OF THE TOWN OF HARTLAND, WISCONSIN REFERRED TO AS: TOWN OF HARTLAND SMART GROWTH COMPREHENSIVE PLAN: 2005 - 2024

The Town Board of the Town of Hartland, Wisconsin, does ordain as follows:

WHEREAS, Pursuant to sections 60.22(3) and 62.23(2) and (3) of Wisconsin Statutes, the Town of Hartland is authorized to prepare and adopt a comprehensive plan as defined in sections 66.1001 (1)(a) and 66.1001 (2) of Wisconsin Statutes.

WHEREAS, The Town Board of the Town of Hartland has adopted and followed written procedures designed to foster public participation during the amendment of the comprehensive plan as required by section 66.1001(4)(a) of Wisconsin Statutes.

**WHEREAS**, The Plan Commission of the Town of Hartland, by a majority vote of the entire Commission recorded in its official minutes, has adopted a resolution recommending to the Town Board the adoption of the amendments to the document entitled "TOWN OF HARTLAND SMART GROWTH COMPREHENSIVE PLAN: 2005 - 2024," containing all of the elements specified in section 66.1001(2) of the Wisconsin Statutes.

**WHEREAS,** The Town of Hartland has held at least one public hearing on this ordinance, in compliance with the requirements of section 66.1001(4)(d) of Wisconsin Statutes, and provided numerous other opportunities for public involvement per its adopted public participation strategy and procedures.

**NOW, THEREFORE, BE IT RESOLVED,** The Town Board of the Town of Hartland, Wisconsin, does, by enactment of this ordinance, formally adopt the amendments to the Element J: Land Use and the section within the document entitled: "TOWN OF HARTLAND SMART GROWTH COMPREHENSIVE PLAN", pursuant to section 66.1001 (4)(c) of Wisconsin Statutes.

This ordinance shall take effect upon passage by a majority vote of the members-elect of the Town Board and publication/posting as required by law.
