## **ORDINANCE 2026-01 REPEAL OF ORDINANCE 2004-01**

### **Section I – Title & Purpose**

The title of this ordinance is the Town of Hartland Repeal of Ordinance 2004-01. The purpose of this ordinance is to repeal Ordinance 2004-01, as the information it contains is no longer valid, and needs to be replaced under the direction of Wisconsin Department of Safety and Professional Services.

### **Section II – Authority and Adoption of Ordinance**

The Town Board of the Town of Hartland, Shawano County, Wisconsin, has the specific authority under §66.0113, Wis stats. To adopt this ordinance.

This ordinance, adopted by a majority of the Town Board on a roll call vote with a quorum present and voting an proper notice having been given, provides the repeal pf Ordinance 2004-01

### **Section III – Repeal**

Ordinance 2004-001 Adoption of Wisconsin Uniform Dwelling Code, enacted on 20<sup>th</sup> of April, 2004, and any of its amendments thereto, are hereby repealed.

### **Section IV – Savings Clause**

The repeal od the above – mentioned ordinance does not affect any rights, duties, penalties, or proceedings (including proescutions) that accrued, existed or were initiated prior to the effective date of the repealer.

### **SECTION V– SEVERABILITY**

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

### **SECTION VI – APPLICABILITY**

This ordinance amends previously passed Town Ordinances and herby incorporates by reference this ordinance into existing Town Ordinances. Where any conflict between Ordinances exists with regard to enforcement of Ordinance violations, this Ordinance is controlling over the other Ordinances.

## **SECTION VI – EFFECTIVE DATE**

This ordinance is effective 2 business days after its final passage, approval and on publication or posting as required by law.

The town clerk shall properly post or publish this ordinance as required under § 6080, Wis. Stats.

This ordinance was adopted at a regular meeting of The Town Board of The Town of Hartland on the 9<sup>th</sup> day of February, 2026, and shall be in force in perpetuity, or until revoked by action of this Board or any succeeding Board thereof.
